




## **News Summary**

- Indian equity markets gave up the healthy gains of the early trading session and closed with mild gains despite having strong global
- Bond yields declined amid optimism in response to a proposal to include eligible domestic bonds to the Bloomberg Emerging Market Local Currency index.
- The World Bank predicted that despite a further global slowdown in 2024, the Indian economy would grow by 6.4% in FY25 and 6.5% in FY26, keeping it as the fastest-growing major economy.
- The Supreme Court sought responses from the Central government and the Directorate General of Goods and Services Tax in response to numerous petitions filed by the online gaming companies challenging the 28% levy on all forms of online gaming.
- The Indian rupee in the spot trade fell against the U.S. dollar due to strong greenback demand.
- Gold prices edged up as a new survey indicating a decline in consumer inflation expectations in the U.S. raised hopes for an imminent shift in the Federal Reserve's monetary stance.
