

## <u>Terms and Conditions for Rs. 500 Grofers voucher on Axis Bank Credit Card approval November</u> 2020

These terms and conditions ("Terms") shall be applicable to the Credit Cardholders (as defined hereinafter) participating in the Offer (as defined hereinafter) who agrees to be bound by the same and shall regulate the provisions of the specified products and services provided by the Axis Bank ("Axis Bank").
