

## Terms and Conditions for Zomato Pro membership on Axis Bank Credit Card approval November 2020

These terms and conditions ("Terms") shall be applicable to the Credit Cardholders (as defined hereinafter) participating in the Offer (as defined hereinafter) who agrees to be bound by the same and shall regulate the provisions of the specified products and services provided by the Axis Bank ("Axis Bank"). Participation in this offer is voluntary. Any User participating in the Offer shall be deemed to have read, understood and accepted these terms and conditions and these Terms shall be in addition to and not in derogation of other applicable terms and conditions of any account or any other facility/services offered by the Bank and/or such other terms and conditions as may be specified by the Bank.

## **Definitions:**

The following words and phrases shall have the meanings set out herein below in this document unless repugnant to the context:

"Credit Cardholders" – A person who is holding the retail Axis Bank Credit Card whose last 4 digits have been mentioned in the communication.

"Campaign Period/ Offer Period/ Validity" - The period for which the offer is valid.

"Transactions" – any usage on the card which is not a charge/fee/interest levied.

"Merchant" – any establishment where the Axis Bank credit card mentioned in the offer has been used for making a purchase.

SMS/Email/Mobile App Push Notification sent by Axis Bank to the customer's registered mobile number/email ID mentioning the offer is referred to as "communication". Only those customers who receive the communication are eligible.

The Campaign Period referred to as "Offer Period" or "Validity", used interchangeably, will be the one mentioned in the communication received by customer.

- Zomato Pro Membership will be issued with the validity of 3 months with Flipkart, MyZone, and Neo Credit Card
- Zomato Pro Membership will be issued with the validity of 12 months with Magnus, Select, and Privilege Credit Card
- The Zomato Pro Membership is issued to the customer whose card is approved and card number is successfully generated.
- The Zomato Pro membership will be directly activated in your Zomato Mobile app and the communication will be sent on your Mobile Number/Email ID registered with Axis Bank

- The validity of Zomato Pro membership will start from the day it is activated in your Zomato mobile App
- By completing the credit card application form, I confirm that I have read and agreed to the detailed Terms and Conditions.
- There is no restriction on the number of times a member can avail the Probenefits in a day.
- Zomato Pro membership can be used only on a single mobile device at a time and may not be used in respect of multiple devices with a single registered email.
- Member must be physically present at the time of redeeming benefit(s). Member must carry a valid ID proof.
- Zomato Pro is not valid on takeaway. Take-away of leftovers is at the discretion of the restaurant partner.
- Partner restaurants may charge additional charges, including but not limited to service charge, which are not covered under Offers at it's own discretion.
- Zomato Pro cannot be combined with other offers.
- Your membership plan will be automatically renewed at the expiration of your membership plan. You can cancel your membership at any time before the expiration of your membership plan.
- Any discounts on the membership are valid for the first purchase only.
- Zomato Pro is not valid on special occasion days (Valentine's Day, Christmas Eve / Christmas Day, New Year's Eve / New Year's Day, Diwali Eve / Diwali Day, Durga Puja (applicable in WB), Pongal (applicable in TN), or on days prohibited by law or applicable regulations.
- Exclusion period applies from the start of operational hours for the day up till 6am of the following day.
- Customer needs to call Axis Bank customer care or reach out through other mediums to get the card related disputes resolved

  Offer including any other applicable terms & conditions modified and prescribe d by Axis
  Bank from time to time. Any such participation by the customer shall imply that the
  customer has read, understood and accepted the terms and conditions hereunder
